6. Irrigation and Treasury report, by Chuck Pabst

- Accounts are healthy. Northridge HOA has \$40,429.27 in the account. Chuck dissolved a CD of \$30,000 in preparation for moving bank accounts, which had previously been under his name. New accounts will not be under anyone's private account.
- Last year the HOA spent \$2,100.00 on cleaning out ditches.
