## Item 3: Amendment to By-Laws to reduce Quorum Requirements

11 Owners voted Yes to Agree to reduce future Quorum Requirements to 33 % from 50 % 1 Owner voted No to Agree to reduce future Quorum Requirements to 33 % to 50 % 2 Owners did not vote.

The proposal to Amend the By-Laws to reduce future Quorum Requirements from 50 % to 33 % was Approved by the Majority of the Quorum. Article II, Item 7 will be revised.
