### Architectural Request for Roof, Paint and/or Finish Projects

The purpose of this form is to facilitate the approval process on home and site improvements submitted to the ACC. Please review Canyon View Estates Covenants, Conditions, and Restrictions (CC&Rs) to assure that your proposed project is compliant to the conditions and restrictions set forth. The homeowner and/or Contractor shall obtain any applicable City of Grand Junction approvals, in writing, and any applicable City Permits. These approvals and/or permits shall be submitted to the ACC prior to commencing work.

#### **CC&R Article V, Paragraph 5.3**

*Duplicate copies of complete plans and specifications, including a construction schedule, relating to a Building or Improvement shall be submitted to the ACC for review and final approval. Plans and specifications shall contain, without limitation, the plot plans showing the layout, including setbacks, flow and manner of surface drainage, finish and natural grade elevations, floor plans showing overall dimensions, roof plans showing pitch, roof materials, color, exterior elevations showing doors, windows and exterior materials and colors and a perspective sketch if requested, and other details necessary to explain the feature or component of the Improvements.*

#### **NOTE:**

*Repairs, replacement or repainting is permitted without the approval of the ACC so long as there is no change from the existing Improvement or change of color (Reference: CC&R Article IV, Paragraph 4.2 M) Please call Tracey Heritage at Western Slope HOA Management at (970) 778-6149 so the HOA knows your intentions.*
